## 2. Important Instructions:

- The candidate must have passed Eight subjects from June 2006 & onward of GCE 'O'-Level, (Eight Subjects including Mathematics, English, Urdu, Islamiyat, Pakistan Studies as compulsory subjects and three elective subjects If he / she appears from Pakistan) and ( five subjects Including Mathematics, English as compulsory subjects and three elective subjects If he/she appeared from abroad). Before 2006 SEVEN subjects were required as Mathematics was not compulsory.
- In case of dual/ foreign national he/she will be exempted in three subjects namely Urdu, Islamiyat, and Pakistan studies and foreign nationality will be mentioned on equivalence certificate.
- As per National Scheme of Studies (SOS-2006) in addition to compulsory subjects of English and Mathematics three Science Subjects are required for (i) SSC (Science Group): Physics, Chemistry, Biology/Computer Science. (ii) HSSC (Pre-Medical Group): Physics, Chemistry & Biology (iii) HSSC (Pre- Engineering Group): Physics , Chemistry & Mathematics (iv) HSSC (Computer Science Group): Physics, Computer Science & Mathematics (v) HSSC (Humanities): Any three Elective subjects
- The student must have SSC/equivalent qualification before applying for HSSC Equivalence. SSC (Science Group) is pre requisite/compulsory for obtaining equivalence certificate of HSSC (Pre-Medical/Pre-Engineering/Computer Science Group). However, the student must study the subject of Biology at SSC level for equivalence of HSSC (Pre-Medical Group).
- The statement of result of 'O' and 'A' levels is valid upto maximum six months only. After six months, original certificate is required and an application without the 'O' levels / 'A' levels certificate will not be entertained. Provisional equivalence will be issued on the basis of Statement of Results.
- FIVE academic subjects at each Junior Certificate and Leaving Certificate are required for equivalence of SSC and HSSC respectively.
- FIVE academic subjects at Standard Grade and FOUR academic subjects at High Grade are required for equivalence of SSC and HSSC respectively.
- SIX Units must be completed at BTEC Level 1, 2 in addition to the compulsory subjects of English and Mathematics for equivalence of SSC (Arts Group) and EIGHTEEN Units must be completed at BTEC Level 3 for equivalence of HSSC (Humanities Group).
- Downloaded result is not acceptable for equivalence, even if result is attested/verified by school.
- In case the examination session is older than FIVE years then certificate(s) must be verified by British Council.
- Name and Date of Birth of applicant must be same on all Certificates and CNIC/Passport.
- If a candidate passes 'O' level from abroad and appears for 'A' level from Pakistan or vice versa. He/She has to pass Urdu, Islamiyat and Pakistan Studies at 'O' level for obtaining Equivalence Certificate.
- For A level equivalence the copy of the Equivalence Certificate of 'O' level issued by IBCC and original 'O' level certificates along with 'A' level certificates must be provided.
- Certificates with plastic coating are not accepted for issuance of SSC/HSSC Equivalence Certificate.
- Documents/certificates/diplomas found fake will be referred to the concerned authorities for strict disciplinary proceedings. All educational documents will be confiscated and student will be penalized as per procedure/Rules.
